Vendor Application/Contract

The signer of this agreement acknowledges his/her company's participation as a vendor in the 2010 SCV National Reunion, to be held at the Anderson Sports & Entertainment Center (ASEC) in Anderson, South Carolina. The applicant agrees to pay the vendor fee as described below:

Reunion Vendor (\$50 per day): This includes one eight foot display area; printed recognition in the conference program; an e-mailing to SCV Manse Jolly Camp 6 members prior to the conference; and conference registration for *one (1)* company representative. The vendor fee does NOT include admission to Luncheons, Grand Ball or other off-property events that involve additional costs.

Please note that this vendor agreement is separate from any sponsorships of meals and/or events that may be offered by the SC Manse Jolly Camp 6.

IMPORTANT NOTE: Vendor displays should be designed as table displays. If yours is a stand-alone display and not a table-top display, it must be no wider than 8 feet. A table will NOT be provided in this case, and space limitations may restrict where your display can be placed. Because of space limitations, this will be strictly enforced. Access to electricity or the Internet may be provided at an additional cost according to prevailing ACSEC rates. You'll need to place AV orders directly with the ASEC.

APPLICANT MUST ENCLOSE a nonrefundable check. This application shall become binding upon acceptance by Manse Jolly Camp 6 and will constitute a binding contract upon the applicant, subject to the terms, rules and regulations set forth in this contract. Terms and Conditions

1. SCV SC Manse Jolly Camp 6 reserves the right to exercise its sole discretion in the acceptance or refusal of applications.
2. SCV SC Manse Jolly Camp 6 vendor program is designed to provide a showcase for products and services either specifically designed for, or customarily used by, Sons of Confederate Veterans. The vendor program is strictly a means of information exchange.
3. The participant agrees that SCV SC Manse Jolly Camp 6 shall have the right to make such rules and regulations, or changes in arrangements, as it shall deem necessary, and to amend some from time to time. SCV SC Manse Jolly Camp 6 shall have the final determination in the enforcement of all rules, regulations and conditions.
4. Exhibits will be installed by 10 a.m. Wednesday, July 21, 2010. No part of an exhibit shall be dismantled or materials removed before 4 p.m. on Saturday July 24, 2009, without special permission from SCV SC Manse Jolly Camp. All tabletops must be vacated by 5 p.m. on July 24, 2010. If the tabletops are not vacated by that time, SCV SC Manse Jolly Camp 6 reserves the right to remove materials and charge the expense to the participant.
5. If the vendor fails to make payments due hereunder when they are due, the tabletop assignment is subject to cancellation or reassignment at the option of SCV SC Manse Jolly Camp 6 without obligation for refund. Should any tabletop remain unoccupied by 10 a.m. on Sunday July 25, 2010, SCV SC Manse Jolly Camp 6 reserves the right to give the tabletop to any other applicant or to eliminate the tabletop, and no refund shall be made to the original vendor. Participants may not assign any tabletop allotted to them and may not advertise or display goods, other than those manufactured, distributed or sold by them in the regular course of business, without authorization of CV SC Manse Jolly Camp 6.
6. No refunds will be granted. In the event the SCV SC Manse Jolly Camp 6 state reunion is canceled due to fire, strikes, government regulations, acts of God or other causes beyond the control of the organization, SCV SC Manse Jolly Camp 6 shall not be held liable for failure to hold the state reunion as scheduled, and SCV SC Manse Jolly Camp 6 shall determine the amount of vendor fees to be refunded.
7. In order to allow unobstructed views of neighboring vendors, participants are not permitted to have their displays exceed the length or width of the tabletop or eight feet in height. Containers can only be stored underneath the skirted tabletop.
8. CV SC Manse Jolly Camp 6 the ASEC or any officers or staff members will not be responsible for the safety or the property of the participants from theft, damage by fire, accident or other causes. Participants are advised to consult their insurance broker for proper coverage on display material from the time it leaves their company's premises until its return. In most cases, a rider can be added to a current policy for a nominal cost. Neither SCV SC Manse Jolly Camp 6 nor the ASEC management nor

any of their officers, agents, employees or representatives, shall be held accountable or liable for, and the same are hereby released from accountability or liability for any damage, loss, harm or injury to the person or any property of the applicant or any of its officers, agents, employees or other representatives, resulting from theft, fire, employees or other causes. Neither SCV Manse Jolly Camp 6 nor the ASEC management will obtain insurance against any such damage, loss, harm or injury.

9. Participants hereby agree to indemnify, defend and protect SCV Manse Jolly Camp 6 and the ASEC management from any and all claims, demands, suits, liability for, any damage, loss, harm or injury to the person or any property of the applicant or any of its officers, agents, employees or other representatives, including but not limited to claims of damage in loss to property, or from or out of any damage, loss, harm or injury to the person or any property of the participant or any of its officers, agents, employees or other representatives.

10. Participants or their agents may not allow any articles to be brought into the ASEC or any act done on the premises that will invalidate the insurance or increase the premium on the policies held by the management of the ASEC, nor permit anything to be done by their employees that will damage the premises, property or equipment of the other participants. No signs or articles can be affixed, nailed, or otherwise attached to walls, doors, etc., in such a manner as to damage them. All vendors are subject to these restrictions. Violations of these rules will void the participant's contract, and the participant will be held liable for any damage resulting from such violations.

11. In order to maintain a businesslike atmosphere, extremely loud noises such as bells, sirens, buzzers, audiotapes, etc., will not be permitted.

12. Promotional activity is limited to the area designated for vendor display.

13. Participants may not schedule other events such as receptions, breakfasts, luncheons or dinners during the official SCV Manse Jolly Camp 6 program hours or while the conference is in progress, unless express permission is granted by ASEC.

These Terms and Conditions become a part of the contract between the vendor and CV Manse Jolly Camp 6. They have been formulated for the best interest of the vendor. SCV Manse Jolly Camp 6 respectfully asks the full cooperation of the vendors. All points not covered are subject to the decision of SCV Manse Jolly Camp 6.
